

2. Billing & Cancellation Agreement

All enrollments must be secured with payment before lessons begin. Payments are accepted online, by phone, or in person. Payment information must be kept up to date. If payment is declined, enrollment will not be confirmed.

TUITION & FEES: All tuition and related fees are non-refundable. Session tuition is divided into monthly payments based on the number of lessons in that month, regardless of closures. When starting mid-month, the tuition will be prorated for the number of remaining lessons in the month. An annual, non-refundable anniversary fee is due in full on your first gymnastics lesson and on each anniversary month thereafter. This fee is fixed and will not be subject to proration under any circumstances, including mid-month enrollments or drop requests. This fee will automatically be added to your monthly payment once a year for the month in which it is due.

AUTOMATIC PAYMENTS: Class payments are automatically charged to the credit card on file on the 20th of the prior month. For example, payment for the month of June will be processed on May 20th. If the 20th falls on a Saturday, tuition will be collected on the Friday prior, or if it falls on a Sunday, it will be processed on the following Monday. Dates may vary based on holidays. A credit card on file is required for monthly payments. If payment is not received by the 1st of the month, the enrollment will be dropped at that time. I hereby authorize this facility to charge my bank or credit card account for each month's tuition and fees.

DECLINED TRANSACTIONS: I acknowledge that a \$10 handling charge will be incurred for any declined transactions and are payable before any further services are given.

FINANCIAL ACKNOWLEDGMENTS: I represent and warrant that if I am purchasing something from Planet Gymnastics that (i) any credit or bank account draft (ACH Draft) information I supply is true and complete, (ii) charges incurred by me will be honored by my credit card company or financial institution, and (iii) I will pay the charges incurred by me at the posted prices, including any applicable taxes, fees, and penalties. I acknowledge that payment for lessons is non-refundable. I understand that upon entering into this agreement, I agree to be liable for and pay each month's tuition and fees. Should I dispute a charge through my financial institution, this will constitute a breach of contract possibly resulting in, but not limited to, penalties, additional fees, collection, legal action, and/or termination of any and/or all current and future services. I acknowledge that I have read and accepted the general and financial policies as stated here. I understand that upon enrollment I am entering into a binding financial agreement with Planet Gymnastics.

MODIFICATION CLAUSE: Planet Gymnastics reserves the right to modify, update, or change any portion of this Billing Agreement at its sole discretion. Enrolled customers will be notified of any material changes via email at least 30 days prior to the effective date of the changes. Continued enrollment in our classes following the effective date of the modifications will constitute your acceptance of the revised terms. If you do not agree with any of the changes, please contact us promptly to discuss your options.
